NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Hotel Parcel Owner, the Condominium Association and Developer hereby declare as follows.

- 1. The foregoing recitals are true and correct and are incorporated herein as if fully set forth hereinafter.
- 2. Exhibit A to the Easement Agreement, containing the legal description of the Hotel Parcel, is hereby amended to remove Hotel Units 604 through 607, inclusive. For purposes of clarity, the revised Exhibit A, as attached to and made a part of this Thirteenth Amendment, contains all the Hotel Parcel as of the date hereof, and such attachment shall be hereinafter deemed to constitute Exhibit A to the Easement Agreement.
