The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Note Holder will choose a new index that is based upon competable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Christe Date, the Note Holder will calculate my new interest rate by adding two and one quartor percentage points (2.250 %) to the Current Index. The Note Holder will then round the result of this addition to the newest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4 (D) below, this rounded amount will be my new interest rate until the

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the Maturity Date at my new interestrate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes
