Assignee agrees to indemnify and hold Assignor harmless against any and all losses, costs and expenses (including reasonable attorneys fees) and liabilities incurred by Assignor in connection with or arising in any manner from Assignee's non-performance of the obligations under the REA assumed hereby by Assignee from and after the Effective Date.

The assignment hereunder is made without any representations or warranties, express or implied, except as may be expressly set forth in that certain Contribution and Subscription Agreement, dated as of February 25, 2015, by and among Assignor and the other parties thereto (the "Contribution Agreement") and subject to the terms of the Contribution Agreement

This REA Assignment and Assumption Agreement (a) may be executed in one or more counterparts, any one of which need not contain the signature of more than one party, but all such counterparts taken together will constitute one and the same instrument and (b) shall be binding on and inure to the benefit of the respective successors and assigns of the parties hereto.
