THE COURT FINDS THAT:

- 1. The structure(s) located on the above-captioned property has/have been wrecked and leveled by the City of Chicago.
- 2. Plaintiff's demolition and other related costs total \$22,407.00.
- 3. The principal amount of Plaintiff's in rem lien against the subject property is \$22,407.00.

IT IS HEREBY ORDERED THAT:

- 1. The ordered entered on February 24, 2015 is amended to reflect Plaintiff's demolition costs and personal money judgment against PARTNERS IN CHARITY is entered in the amount of \$22,407.00.
