### IT IS HEREBY ORDERED THAT:

- 1. As to Plaintiff's demolition costs, a personal money judgment is entered against FIRST S & H MANAGEMENT, LLC in the amount of \$11,337.00. This judgment is separate from and in addition to any other judgments previously entered by the Court in this matter.
- 2. Plaintiff may file a petition to foreclose its demolition lien in this proceeding, either instanter or at a later date, and the Court retains jurisdiction over this case solely for the purpose of adjudicating the foreclosure. Plaintiff retains the right to file its foreclosure under the Mortgage Foreclosure Act of Illinois in a separate proceeding.
