units under item #5 of said Contract, on a roofing area referred to as "Roof C & D," located on

the Real Estate, all for the sum of \$10,035.

4. The Contract was entered into by Brennan Management as Owner's agent.

5. The Contract work was performed with the knowledge, authorization and/or consent of

Owner.

6. Claimant completed all work under the Contract on December 20, 2014. Thereafter,

Owner and/or Owner's agents failed to make any payment for the work completed and invoiced

under the Contract.

7. As of the date hereof, there being no offsets or credits, there is due, unpaid, and owing to

Claimant, the principal sum of \$10,035 which principal sum bears interest at the statutory rate of

10 percent per annum. Claimant claims a lien hereunder on the Real Estate (including all land

and improvements thereon) in the amount of \$10,035 plus interest.

8. Claimant revokes any waiver of rights for which claimant has not received payment.
