THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.

Borrower and Lender covenant and agree as follows:

UNIFORM COVENANTS:

1. Payment of Principal, Interest and Late Charge

Borrows, shall promptly pay when due the principal of, and interest on, the debt evidenced by the Note and late changes due under the Note.

2. Monthly Pay neut of Taxes, Insurance and Other Charges

13. Notices

16. Hazardous Substances
