

- 3. At all times relevant hereto, and at the time the Contract was entered into between CLAIMANT and NF:
  - A. NF was acting as OWNER's General Contractor or Agent, and the work was done with the knowledge and consent of the OWNER;

B. Alternatively, the OWNER authorized NF to enter into the Contract;

- C. Alternatively; the OWNER knowingly permitted NF to enter into the Contract for the improvement of the Real Estate.
- 4. Pursuant to said Contract, furnished materials and performed labor for and upon the premises.
- 5. The CLAIMANT has completed performance of it's contract in that it has provided the materials and labor and has delivered and installed all the materials required under the contract to the site of the improvements on the above-described property.

- 6. CLAIMANT did so provide the Work under the Contract and substantially completed and last performed all such Work on **April 9, 2015**, for which CLAIMANT hereby claims a lien under the Contract.

That said NF Demolition Inc. has paid nothing to CLAIMANT, leaving due, unpaid and owing to the CLAIMANT on account thereof, after allowing all credits, a balance of Five Thousand Eight Hundred and No/100 Dollars (\$5,800.00.00), plus attorney's fees, and statutory interest, for which the CLAIMANT claims a Lien on said land and improvements.
