QUITCLAIM DEED

CITY OF CHICAGO, an Illinois municipal corporation having its principal office at 121 North LaSalle Street, Chicago, Illinois 60602 ("Grantor"), for and in consideration of ONE DOLLAR (\$1.00), pursuant to an ordinance adopted by the City Council of the City of Chicago, on March 18, 2015, conveys and quitclaims all right, title and interest in the real property legally described and identified on Exhibit A attached hereto ("Property") to Andrew Pratus and Vanessa Maya, individuals (together, "Grantee"), having its or their principal office or residence at 3104 W. Walnut St., Chicago, IL 60612.

- 2. general real estate taxes and any special a sessments or other taxes;
- 3. easements, encroachments, covenants, restrictions and liens of record and not shown of record;
- 4. such other title defects as may exist;
- 5. any and all exceptions caused by acts of Grantee or its agents; and
- 6. if the Property is located in a redevelopment area, then the conveyance also is subject to the redevelopment plan, as may be americal, for the Tax Increment Financing District Redevelopment Area in which the Property is located, until such plan expires.

This deed is also subject to the following covenant which is a part of the consideration for the Property and which shall run with the land and bind Grantee and Grantee's successors and assigns:

For a period of five (5) years commencing on the date of this deed, Grantee shall (a) remain in title to the Property and (b) maintain the Property. Grantor shall have a right of reverter if Grantee or Grantee's successors and assigns fail to comply with such covenants.
