### THE COURT FINDS THAT:

- 1. The structure(s) located on the above captioned property has/have been wrecked and leveled by the City of Chicago.
- 2. Plaintiff's demolition and other related costs total \$22,407.00.
- 3. The principal amount of Plaintiff's in rem lien against the subject property is \$22,407.00.

### IT IS HEREBY ORDERED THAT:

- 1. The ordered entered on February 24, 2015 is amended to reflect Plaintiff's demolition costs and personal money judgment against PARTNERS IN CHARITY is entered in the amount of \$22,407.00. This judgment is separate from and in addition to any other judgments previously entered by the Court in this matter.
- 2. Plaintiff may file a petition to foreclose its demolition lien in this proceeding, either instanter or at a later date, and the Court retains jurisdiction over this case solely for the purpose of adjudicating the foreclosure.
