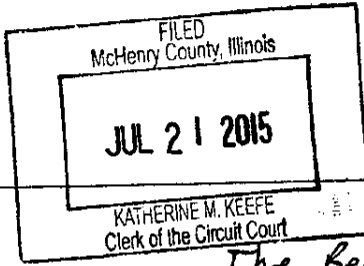

THIS MATTER coming before the Court for decision on the motion to withdraw the body attachments for Efsthios and Elaine Regopoulos, IT IS HEREBY ORDERED:

1. The body attachments against Efsthios and Elaine Regopoulos are withdrawn.
