

- 3. The subject building is dangerous, unsafe and beyond reasonable repair under the terms of the Illinois Municipal Code, 65 ILCS 5/11-31-1 (1996) (Unsafe Buildings), in that:
 - a. The building is vacant and open.
 - b. The building's masonry has washed out mortar joints.
 - c. The building's window glazing is broken or missing.
 - d. The building's window sashes are broken, missing and inoperable and have smoke, fire or water damage.
 - e. The building's roof has a damaged membrane and water damage.
 - f. The building's strir system has damaged decking, damaged handrails, and smoke, fire or water damage.
 - g. The building's stair system hes improper handrail height and improper tread and riser.
 - h. Sections of the building's flooring have smoke, fire, or water damage.
 - i. The building's plaster is broken or mis ing and has smoke, fire, or water damage.
 - The building's studs are missing.
 - k. The building has no working mechanical systems, including electrical, plumbing, and heating.
 - 1. The building's electrical fixtures are missing, and exposing wiring
 - m. The building has no ductwork or furnace.
 - n. The building's heating system is stripped, vandalized and is inoperable.
 - o. The building's plumbing fixtures are missing, stripped and inoperable.



- 4. There has been no work in progress since the beginning of this case at the subject property.
- 5. The Court finds that it would take major reconstruction of a responsible owner to bring the subject building into full compliance with the Municipal Code, and that the subject building is beyond reasonable repair. The Court further finds that demolition of the subject building is the least restrictive alternative available to effectively abate the conditions now existing there.

WHEREFORE, IT IS HEREBY ORDERED THAT:

- A. Judgment is entered in favor of Plaintiff City of Chicago and against Defendants on Counts I and IV of the City's complaint seeking demolition authority.
- B. The remaining counts of the City's complaint are voluntarily withdrawn.
- C. Pursuant to the judgment entered above, 65 ILCS 5/11-31-1, and the City's police powers under Article VII of the Illinois Constitution, the City is granted authorization to demolish the building on the subject property and is entitled to a lien for the costs of demolition, court costs, and other costs enumerated by statute, and/or other statutory remedies.
- D. The authority granted in Paragraph C. above shall become effective ____ I Muelia !
- E. The City's performance under this order will result in a statutory <u>in rem</u> lien that attaches only to the subject parcel of real estate. If the City seeks a personal judgment against any individual party to this action, it will proceed by separate motion directed to that party.
- F. Defendants with either possession or control of the subject property shall immediately remove any and all persons occupying the subject property and all personal property from said premises instanter so that said premises will be completely vacant and the of personal property before demolition is commenced. The City's Department of Human Services is authorized to assist in the relocation of any tenants.
- G. Pursuant to Illinois Supreme Court Rule 304(a), this is a final and appealable order and the Court finds that there is no just reason for delaying the enforcement or appear of his order.
- H. The Court reserves jurisdiction of this cause to enforce the terms of alice order and for the purpose of ascertaining the demolition costs for entry of a money judgment against the defendant owners, as defined by the applicable statutes and ordinances.
