SUBORDINATION

THIS SUBORDENATION ("Subordination") is made as of this 8th day of July 2015, by CITY OF CHICAGO, an Illinois municipal corporation and home rule unit of local government, having its principal office at 121 N. LaSalle Street, City Hall, Room 1000, Chicago, Illinois 60602 (the "City").

EECITALS

WHEREAS, Chicago Metropolitan Development Association, an Illinois not-for-profit corporation ("Developer"), and the City have previously entered into that certain "Redevelopment Agreement - New Homes for Chicago Program - Chicago Metropolitan Development Association" dated as of November 30, 2001, and recorded on December 6, 2001 in the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office"), as document number 0011151889 (the "Redevelopment Agreement"), and

WHEREAS, pursuant to the Redevelopment Agreement, the City previously sold to the Developer certain real property legally described in Exhibit A of the Redevelopment Agreement, including the parcel of land legally described in Exhibit 1 of this Subordination (the land legally described in Exhibit 1, the "Property"); and

WHEREAS, <u>Lupeda Calhoun</u> (n/k/a Lupeda T. Brown) ("Mortgagor") purchased the Property from Developer; and

WHEREAS, in order to assist Mortgagor in the purchase of the Property from Developer, the City, pursuant to the Redevelopment Agreement, provided Mortgagor with certain subsidies; and

WHEREAS, at closing, and as a pre-condition to the purchase of the Property by Mortgagor, the Mortgagor executed a mortgage in the amount of Twenty-Seven Thousand Eight Hundred Thirty-Two and 00/100 Dollars (\$27,832.00) in favor of the City, dated as of January 31, 2007 and recorded with the Recorder's Office on February 27, 2007 as Document No. 0705826115 (the "City Mortgage"); and
