#### CONSENT JUDGMENT PURSUANT TO 735 ILCS 5/15-1402

THIS CAUSE coming on to be heard on Motion of the parties for the entry of a Consent Judgment of Foreclosure pursuant to 735 ILCS 5/15-1402, the defendant Roxanne Summers (herein "Defendant") having expressly consented to said judgment and the Court finding as follows:

- 1. That the mortgage Defendant has expressly consented to the entry of this Consent Judgment of Foreclosure.
- 2.
