The entry of this Agreed Order shall in no way affect any proceedings or license disciplinary action at the City of Chicago Department of Business Affairs and Consumer Protection, including but not limited to Case Number 15 LR 2 and Case Number 15 LR 56, in that DJJ Entertainment, Inc. has already surrendered its City of Chicago business licenses without admitting liability in said license disciplinary actions.
- 4. The court reserves jurisdiction of this matter for the purposes of modification, enforcement, or termination of this Agreed Order, including the adjudication of proceedings for contempt for failure to pay said costs, which could result in the imposition of a fine and/or incarceration against Defendant(s), and reinstatement of City's Complaint.
