LEGAL DESCRIPTION

Parcel 1:

Parcels 9 and 10 (excepting from said Parcels 9 and 10 those portions thereof lying Southwesterly of a line drawn parallel to and 105 feet Northeasterly, by rectangular measurement, from the Northeasterly line of the right of way conveyed to Chicago and Calumet terminal railroad on July 22, 1989, by Charles S. Lane and others by deed recorded as Document 1134427) in Cicero Avenue Acres, being a subdivision of part of the Southeast ¼ of Section 21, Township 37 North, Range 13 East of the Third Principal Meridian, according to the Plat thereof recorded March 26, 1928 as Document 9967574, in Cook County, Illinois.
