ORDINANCE NO. 2015-9-1-0

**AN ORDINANCE ANNEXING
CERTAIN TERRITORY TO THE
STREAMWOOD PARK DISTRICT**

WHEREAS, Section 3-9 of the Illinois Park District Code ("Code"), 70 ILCS 1205/3-9 authorizes park districts to annex territory containing 80 acres or less that is not incorporated within a park district and is wholly bounded by one or more park districts, or is wholly bounded by one or more park districts and a river, lake, railroad, or arterial street; and

is not incorporated within a park district and is wholly bounded by the Streamwood Park District ("Park District"); and

WHEREAS, in accordance with the procedures described in Section 3-9 of the Code, the Park District has caused to be published in a newspaper of general circulation not more than 45

nor less than 30 days before the passage of this ordinance a notice of which a certified copy is attached hereto as Exhibit A; and

WHEREAS, the Streamwood Park District Board of Park Commissioners finds that it is in the best interest of the Park District that said Territory be annexed in to the Streamwood Park District;

NOW THEREFORE, BE IT ORDAINED by the President and Board of Commissioners of the Streamwood Park District, Cook County, Illinois, as follows:

SECTION 1: That the Territory legally described in Exhibit B attached hereto is hereby annexed to the Streamwood Park District.

SECTION 2: That the Secretary of the Streamwood Park District is hereby directed to record in the Office of the Recorder of Deeds of Cook County, Illinois, and to file in the office of the County Clerk of Cook County, Illinois, being the County in which the Territory is situated, a certified copy of this Ordinance, together with an accurate map of the Territory hereby annexed, said map being attached hereto as Exhibit C.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval and when a certified copy thereof, together with an accurate map is recorded in the Office of the Recorder of Deeds of Cook County, and filed in the office of the County Clerk of Cook County; and thereupon, said territory shall be subject to the jurisdiction of the Streamwood Park District.



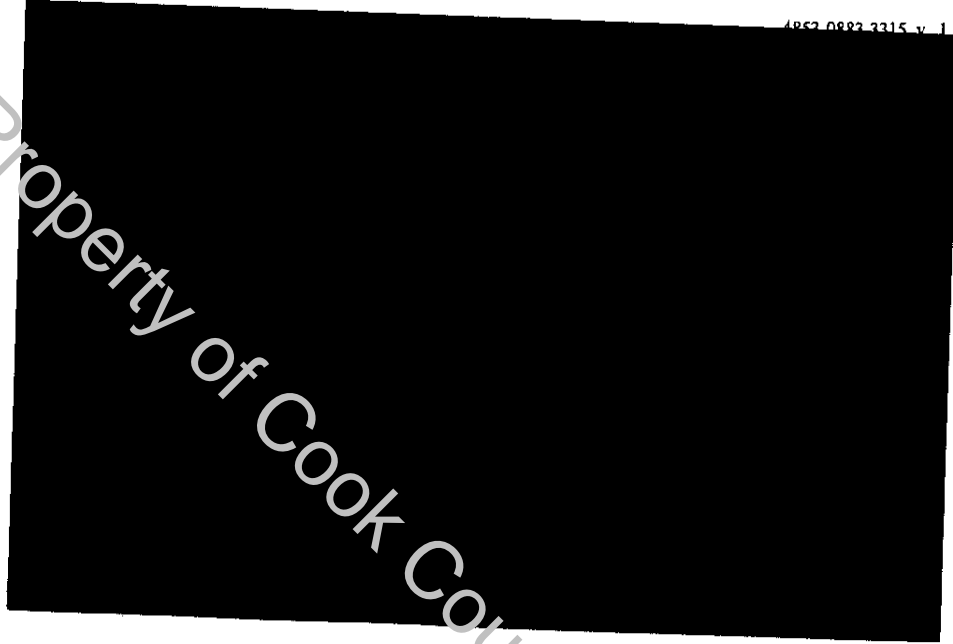

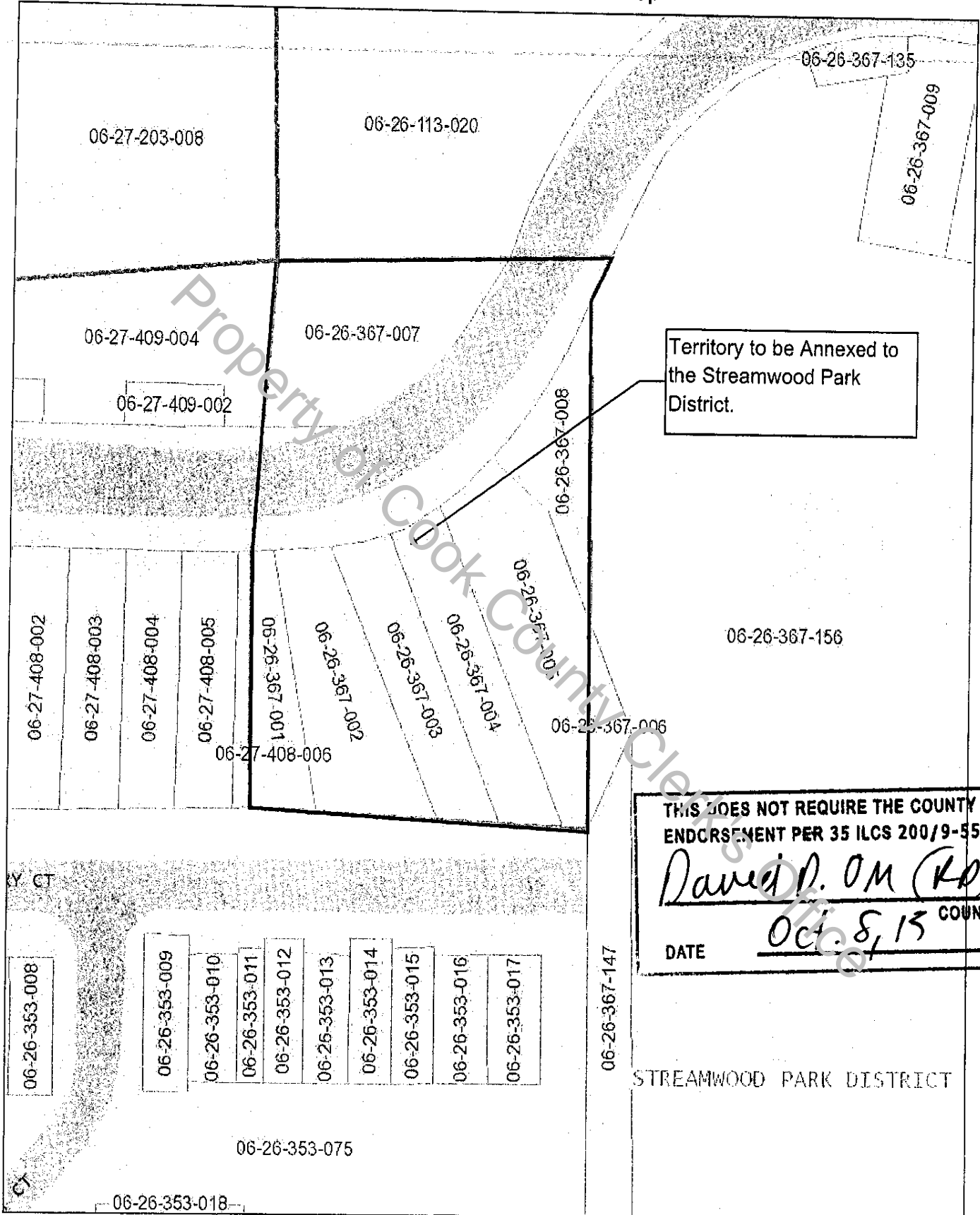
MAP OF ANNEXATION
