This cause came on to be heard on the ______ day of January, 2014, before the Honorable Ronald Thurman, Chancellor for the Chancery Court of Cumberland County, Tennessee, upon the Plaintiff's Sworn Complaint, the Answer and Motions filed by the Defendants, the statements of counsel, and the entire record in the cause, from all of which it appears to the Court that the Defendants have been regularly brought before the Court by personal service of process through the Tennessee Secretary of State under the Long-Arm Statute codified at Tennessee Code Annotated §20-2-214. the Defendants' counsel, Jim Terry, was allowed to withdraw from the cause and the Defendants were given thirty (30) days to obtain alternate counsel. No alternate counsel made an appearance for the Defendants. The Defendants were properly notified of the trial setting and failed to appear.

The Plaintiff announced a voluntary dismissal as to the Defendants, MHV, LLC; VVM, LLC; MAM, LLC; UVM, LLC; and, MAV, LLC.

It appears to the Court that the Plaintiff is justly entitled to the relief sought in the Complaint as to the Defendants, Vikram Mehta, Dr. Harsha Mehta, and Veerayatan Sarvoday Tirtham, Ltd., and that those Defendants, and each of them, are indebted to the Plaintiff under the Contract described in the Complaint and/or under oral agreements predating the Contract described in the Complaint, in the sum of \$176,948.98, as of the date of the filing of the Complaint. The Court turther finds that this is a proper case in which the Plaintiff should be awarded pre-judgment interest on the amount due at the time of the filing of the Complaint at a rate of 4% per annum from March 12, 2010, being the date of the filing of the Complaint, to the date of the entry of this Order. Accordingly, the Court finds that the Defendants, Vikram Mehta, Dr. Harsha Mehta, and Veerayatan Sarvoday Tirtham, Ltd., are indebted to the Plaintiff as follows:
