If the Index is no longer available, the Mortgagee will choose a new Index which is based upon comparable information. The Mortgagee will give the Mortgagor notice of its choice.
(3) Before each Change Date, the Mortgagee will calculate the new interest rate by adding **Three And One-Quarter** percentage points (****3.25%******) to the Current Index. The sum will be the new interest rate.
