#### A RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO EXECUTE AN OPEN SPACE CONSERVATION EASEMENT WITH SHIR HADASH SYNAGOGUE 200 W. DUNDEE ROAD

WHEREAS, the Village of Wheeling approved Ordinance No. 4754 on February 4, 2013, granting special use and site plan approval for religious assembly for Shir Hadash Reconstructionist Synagogue – Congregation Shir Hadash, to be located at 200 W. Dundee Road; and

WHEREAS, Ordinance No. 4754 was subsequently amended on December 15, 2014, through the approval of Ordinance No. 4910, which extended the land area for the synagogue to include additional open space along Buffalo Creek to the northeast of the synagogue building; and

WHEREAS, in conjunction with the building permit and associated final engineering plans for the adjacent building, the Whitley of Wheeling Memory Care and Assisted Living Facility, owned and developed by the LaSalle Group, the open space must be maintained in perpetuity; and

WHEREAS, Congregation Shir Padash and the LaSalle Group have prepared documents granting perpetual Open Space Conservation Easements to the Village of Wheeling; and

**WHEREAS**, the execution of said easements is in the best interests of the Village of Wheeling and authorized by law;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WHEELING, COUNTIES OF COOK AND LAKE, STATE OF ILLINOIS that the Village manager is hereby authorized to execute an Open Space Conservation Easement with Shir Hadash Synagogue, attached hereto, for the synagogue property at 200 W. Dundee, specifically applicable to the open space area as described in the easement document.
