- (j) "Community Association Dues, Fees, and Assessments near all dues, fees, assessments and other charges that are imposed on Borrower or the Property by a condominion association, homeowners association or similar organization.
- (K) "Electronic Funds Transfer" means any transfer of funds, other than a transaction originated by check, draft, or similar paper instrument, which is initiated through an electronic terminal, telephonic instrument, computer, or magnetic tape so as to order, instruct, or authorize a financial institution to depict or credit an account. 2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order in which it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due under this Cocurity Instrument, and then to reduce the principal balance of the Note.

If Lender receives a paymer, from Borrower for a delinquent Periodic Payment which includes a sufficient amount to pay any late charge due, the pay nent may be applied to the delinquent payment and the late charge.
