ORDINANCE NO. 15-1638 VILLAGE OF NORTHFIELD COOK COUNTY, ILLINOIS

ANNEXING CERTAIN PROPERTY LOCATED ON THE WEST SIDE OF SUNSET RIDGE NORTH OF WILLOW ROAD COMMONLY KNOWN AS 6 ROLLING RIDGE ROAD

BE IT CRDAINED by the President and Board of Trustees of the Village of Northfield, Cook County, Illinois, as follows:

SECTION 1. FINDINGS: The President and Board of Trustees find as follows:

- (a) A petition has been filed with the Village Clerk and presented to the President and Board of Trustees of the Village of Northfield, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Northfield, Cook County, Illinois (the "Petition").
