## NOTICE AND CLAIM FOR COMMERCIAL REAL ESTATE BROKER'S LIEN

- 5. Pursuant to the Agreement with Owner, a total of \$58,514.40 was due Broker for providing the aforesaid licensed services, \$29,257.20 of which was due upon execution of the Lease Agreement between Owner and CHMG, and \$29,257.20 of which was due upon the tenant taking possession of the premises, which occurred on or about October 7, 2015. Owner paid the initial \$29,257.20, but as of the filing of this lien still owes Broker the remaining \$29,257.20.
- 6. Broker now claims a lien upon the Property in the amount of \$29,257.20 for the licensed services provided.
