# AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP FOR WILSHIRE WES? CONDOMINIUM ASSOCIATION

This instrument, consisting of \_\_\_\_\_(\_\_\_) pages, is recorded for the purpose of amending the Declaration of Condominium Cwnership Wilshire West Condominium Association (hereinafter referred to as "Declaration"), which vas recorded on July 11, 1974 as document number 22779634 with the Recorder of Deeds of Cook County, Illinois.

This Amendment is adopted pursuant to the provisions of Section 24 of said Declaration. Section 24 provides that the provisions of the Declaration may be changed, modified, or rescinded upon the recording of an instrument in writing setting forth such change, modification or rescission, signed and acknowledged by Unit Owners having at least three-quarters (3/4) of the total votes and certified by the Secretary of the Board; provided, however, that all lien holders of record have been notified by certified mail of such change, modification or rescission, and an affidavit by said Secretary certifying to such mailing as a part of such instrument.

### **PREAMBLE**

WHEREAS, the Declaration of Condominium Ownership for the Wilshire West Condominium Association was recorded on July 11, 1974 as document number 22779634 with the Recorder of Deeds of Cook County, Illinois; and

WHEREAS, the Board for Wilshire West Condominium Association (hereinafter referred to as "Association") and the Owners now desire to amend the Declaration in order to provide for certain restrictions on the leasing of Dwelling Units; and

WHEREAS, the Amendment has been signed and acknowledged by Unit Owners having at least three-quarters (3/4) of the total votes and certified by the Secretary of the Board; and that all lien holders of record have been notified by certified mail of such change, modification or



rescission, and an affidavit by said Secretary certifying to such mailing is attached to this instrument.

NOW THEREFORE, the Declaration of Condominium Ownership for the Wilshire West Condominium Association is hereby amended in accordance with the text that follows:

### **AMENDMENT**

1. The Declaration is hereby amended by deleting Section 21"Sale or Lease by a Unit Owner – First Option to Board:" in its entirety, and the following Section 21 "Sale by a Unit Owner – First Option to Board/Further Limitation on Leases" is substituted in its place which shall read as follows and snell constitute the entirety of Section 21 of the Declaration:

### 21 (A) <u>SALE BY A UNIT OWNER – FIRST OPTION TO BOARD:</u>

- (1) If any Unit Owner (the "Optionor"), other than the Trustee or Developer, shall desire at any time to sell his Unit Ownership, other than to a co-owner of the same Unit, or to a person related by blood or marriage to the Optionor, the Optionor shall first give the Board at least thirty (30) days' prior written notice of the proposed sale, which notice shall state the name and address and financial character references of the proposed purchaser and the terms of the proposed sale. During the period of thirty (20) days following the receipt by the Board of such written notice (the "Option Teriod"), the Board shall have the first right, at its option, to purchase such Unit Ownership upon the same terms as the proposed sale described in such notice.
- The Board may exercise its option to purchase such Unit Ownership by obtaining the consent of two-thirds (2/3) of the Unit Cwnerships, and by giving written notice thereof to the Optionor within the Option Percel. The Board may, by a vote or written consent of the majority of the Directors then serving, choose not to exercise the option. If the Board gives written notice to the Optionor of its election not to exercise its option (which notice shall be executed by any Director and acknowledged by the Secretary of the Association), or if the Board fails to give the Optionor written notice within the Option Period, then the Cptionor shall have ninety (90) days from the date of the expiration of the Cption Period to consummate the proposed sale of his Unit Ownership upon the terms described in the notice to the Board, and if the Optionor fails to so consummate said sale, his Unit Ownership shall again become subject to the Board's option as herein provided.
- (3) If the Board exercises its option hereunder, the Board shall have the authority to make such mortgage or other financing arrangements, and to make such assessments proportionately among all the Unit Owners other than the Optionor, and to make such other arrangements, as the Board may deem desirable in order to close and consummate the purchase of such Unit Ownership by the Board. The Board or its nominee shall hold any Unit Ownership purchased hereunder for the benefit of the Unit Owners upon such terms as the Board shall deem desirable, and

all of the net proceeds or deficit therefrom shall be applied among, or charged to, the Unit Owners in accordance with their Percentages of Ownership.

- (4) A certificate executed and acknowledged by the acting President or Secretary of the Board, stating that the provisions of this Section 21 (A) as hereinabove set forth have been met by an Owner, or duly waived by the Board, and that the rights of the Board hereunder have terminated, shall be conclusive upon the Board and the Owners in favor of all persons who rely thereon in good faith, and such certificate shall be furnished to any Owner who has, in fact, complied with the provisions of this Article or in respect to whom the provisions of this Article have been waived, upon request at a reasonable fee not to exceed Ten Dollars (\$10.00). If any sale of a Unit Ownership is made or attempted by any Unit Owner without complying with the foregoing provisions, such sale shall be subject to each and all of the rights and options of the Board hereunder and each and all of the remedies and actions available to the Board hereunder or at law or in equity in connection therewith.
- (5) For the purposes of this <u>Section 21</u>, the term "Optionor" shall include any beneficiary of a trust, shareholder of a corporation or partner of a partnership holding legal title to a Unit Ownership, and the term "Unit Ownership" shall include the beneficial interest, shares or partnership interest, as the case may be, held by such Optionor.
- (6) The right of the first efusal provided for in Section 21 of this Declaration shall not apply to any sale, gift Levise or other transfer by the Trustee or Developer or by a mortgagee who has obtained title to a Unit Ownership by foreclosure or deed in lieu of foreclosure.

### (B) FURTHER LIMITATIONS ON LEASES:

- (1) Prohibition against Leasing. Each Owner shall occupy and use his/her Dwelling Unit as a private dwelling. Remotion leasing of the Dwelling Units is prohibited, except as hereinafter provided. For purposes of this Section rentals or leasing to a member of the Owner's immediate family members, limited to, children, grandchildren, siblings or parents shall not be prohibited or restricted by the Association.
- (2) <u>Hardship Provisions</u>. In the event that an Owner, due to job-related transfer, medical or health reasons, or other justifiable cause constituting a hardship, in the sole discretion of the Board, shall be unable to occupy the Dwelling Unit for a period in excess of six (6) months and based on said hardship desires to lease said Dwelling Unit, the Owner shall make application to the Board which may, by majority vote and review of the application, grant to the Owner an exception to the above leasing restriction, upon such conditions as the Board may establish and uniformly apply.
- (3) <u>Grandfather Existing Units.</u> Provided the Owner is in compliance with paragraph (5) below, paragraphs (1) and (2) of this Section shall not apply

to any Units which are not Owner occupied as of the effective date of this Amendment and such Units may continue to be leased to the present tenant or any future tenant, provided all other rules and regulations are followed. However, when the ownership of such Units grandfathered by this provision are conveyed, sold, transferred or otherwise hypothecated to an owner who occupies the Unit, the restrictions and prohibitions contained in paragraphs (a) and (b) of this section shall apply to any such future Owner and the Unit.

- (4) <u>Association Leases</u>. The Association shall be exempt from any lease restrictions provided in paragraphs (1), (2), and (3) of this Section, pursuant to the Illinois Forcible Entry and Detainer Act (735 ILCS 5/9-101 et. seq.) for the purposes of collecting delinquent assessments, costs, fees and other property assessed expenses to the Dwelling Unit. Additionally, any lease of a Unit, whether subject to paragraph (3) or pursuant to a weiver, shall be subject to the Board's option under Section 3.09 of this Declaration.
- (5) <u>Recognition of Leased Dwelling Units.</u> In addition, paragraph (1) shall also apply o a'l Owners currently leasing Dwelling Units unless:
  - i. A copy of the Unit Owner's current lease for Dwelling Unit was on file with the Association and for its managing agent as of the date of recording this Amendment;
  - ii. The Unit/Unit Owner is in compliance with all Village of Indian Head Park, County of Cook and State of Illinois codes, ordinances and/or statutes concerning residential property;
  - iii. The Unit Owner has provided proof of (ii) above to the Association and/or its managing agent as of the late this Amendment is recorded and further maintains proof of the same on file with the Association as long as the Unit is being leased pursuant to paragraph (2).
- (6) General Provisions. Additionally, all Owners leasing their Dwelling Unit under such "hardship" exception or pursuant to paragraph (?) shall deliver a copy of the signed lease to the Board, no later than the date of occupancy or ten (10) days after the lease is signed, whichever comes first. Further, all such leases must be in writing and no Dwelling Unit may be leased for a period of less than twelve (12) months or for transient or hotel purposes. In the event that the Owner fails to comply with such leasing requirements, the Association may seek to evict a tenant from the Dwelling Unit under Article IX of the Code of Civil Procedure. Furthermore, all provisions of the Declaration, By-Laws and Rules and Regulations shall be applicable to any person leasing a Dwelling Unit and shall be deemed to be incorporated in any lease executed or renewed. The Board may proceed directly against a tenant, at law or in equity under the provisions of Article IX of the Code of Civil Procedure, for any other breach by tenant of any covenants, rules, regulations or by-laws.

- 3. The terms used herein, if not otherwise defined, shall have the same meaning described to them in the Declaration and By-Laws.
- 4. The language of this Amendment shall govern any conflicts between this document and the prior Declaration and its amendments.
- 5. Except as to the extent expressly set forth herein above, and as amended, the Declaration, By-Laws and Rules and Regulations shall continue in full force and effect without change.
