

- I am the attorney for the Village of Bridgeview, Cook County, State of Illinois. 1.
- The Village of Bridgeview is scheduled to hold a public hearing on the approval of an annexation agreement governing the property commonly known as 7148 West 72nd Street, Cook County, Illinois and legally described in Exhibit "A" ("Territory"), and thereafter will consider the passage of an ordinance annexing the Territory to the Village of Bridgeview. These actions are scheduled for February 3, 2016.
- The Village of Bridgeview provides fire protection services to the Territory; the Territory is not serviced by a fire protection district.
- The Village of Bridgeview does provide public library services. On January 20, 2016, notice of the proposed annexation was provided, in writing, to the Trustees of the Prairie Trails Public Library District by certified mail, return receipt requested, pursuant to 65 ILCS 5/7-1-1.
- Notice was also provided, in writing, to the township supervisor, township clerk, township commissioner of highways, and the township board of trustees of Stickney Township, by certified mail, return receipt requested, pursuant to 65 ILCS 5/7-1-1.
- I have personal knowledge of the foregoing and could competently testify thereto.
- I have read the above and foregoing affidavit, and that matters and statements contained herein are true and correct to the best of my knowledge and belief.
