SUBORDINATE MORTGAGE

This Subordinate Mortgage is subordinate to the lien of the mortgage recorded on April 3, 2002 and recorded in Book/Liber 2896, Page 1104, Instrument No: 0020379185, of the Official Records (Name of Records) of COOK County, IL (County and State, or other Jurisdiction).

THIS SUBORDINATE MORTGAGE ("Security Instrument") is given this 11th day of December, 2015. The Mortgagor is DELFINO SALTO and GLORIA MARQUEZ, whose address is 5400 S KILDARE AVE, CHICAGO, IL 60632 ("Borrower"). This Security instrument is given to the Secretary of Housing and Urban Development, whose address is 451 Sevento Street SW, Washington, DC 20410 (herein "Lender"). Borrower owes Lender the principal sum of THIRTY TWO THOUSAND ONE HUNDRED SIXTY ONE AND 14/100 Dollars (U.S. \$32,161.14). - 1. Payment of Principal. Borrower shall pay when due the principal of the debt evidenced by

Any Borrower who co-signs this Security Instrument but does not execute the Note: (a) is co-signing this Security Instrument only to mortgage, grant and convey that Bonover's interest in the Property under the terms of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the term of this Security Instrument or the Note without that Borrower's consent.

Any notice provided for in this Security Instrument shall be deemed to have been given to Borrower or Lender when given as provided in this paragraph.
- 5. Governing Law; Severability. This Security Instrument shall be governed by Federal law and the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Security Instrument or the Note conflicts with Applicable Law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note are declared to be severable.
- 6. Borrower's Copy. Borrower shall be given one conformed copy of the Note and of this Security Instrument.

NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

7. Acceleration; Remedies. Lender shall give notice to Borrower prior to acceleration following Borrower's breach of any covenant or agreement in this Security Instrument. The notice shall specify: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Security Instrument, foreclosure by judicial proceeding and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of Borrower to acceleration and foreclosure. If the default is not cured on or before the date specified in the notice, Lender at its option may require immediate payment in full of all sums secured by this Security Instrument without further demand and may foreclose this Security Instrument by judicial proceeding. Lender shall be entitled to collect all expenses incurred in pursuing the remedies provided in this Section 7, including, but not limited to, reasonable atterneys' fees and costs of title evidence.

If the Locdor's interest in this Security Instrument is held by the Secretary and the Secretary requires furnediate payment in full under Paragraph 4 of the Subordinate Note, the Secretary may invoke the non-judicial power of sale provided in the Single Family Mortgage Foreclosure Act of 1994 ("Act") (12 U.S.C. 3751 et seq.) by requesting a foreclosure commissioner designated under the Act to commence foreclosure and to sell the Property as provided by the Act. Nothing in the preceding sentence shall deprive the Secretary of any rights otherwise available to Lender under this paragraph or applicable law.

- 8. Release. Upon payment of all sums secured by this Security Instrument, Lender shall release this Security Instrument. Borrower shall pay environments.
- 9. Waiver of Homestead. In accordar ce with Illinois law, the Borrower hereby releases and waives all rights under and by virtue of the Illinois horr es ead exemption laws.
- 10. Bankruptcy Discharge. If Borrower, subsequent to December 11, 2015, receives a discharge in a Chapter 7 bankruptcy, and there is no valid recifirmation agreement of the underlying debt, Lender will not attempt to re-establish any personal liability for the underlying debt.
