
Payments. Mortgagor agrees that all payments under the Secured Debt will be paid when due and in accordance with the terms of the Secured Debt and this Security Instrument.

Prior Security Interests. Mortgagor appoints Lender as attorney in fact to sign Mortgagor's name or pay any amount necessary for performance.
