You have inquired as to whether it is necessary to apply for and receive a Certificate of Payment in the situation where the controlling interest in a limited liability corporation is being transferred and the limited liability corporation owns real property in the Village of South Holland. I have accepted a copy of Sec. 6-310 of the South Holland Village Code. The Village of South Holland only acquires that a Certificate of Payment be obtained where a parcel of real estate is being transferred at a new owner. The transfer of the controlling interest that you described does not require a Certificate of Payment.
