569. The Activity and this lien are occasioned by neglect of maintenance on the Property after reasonable notice.





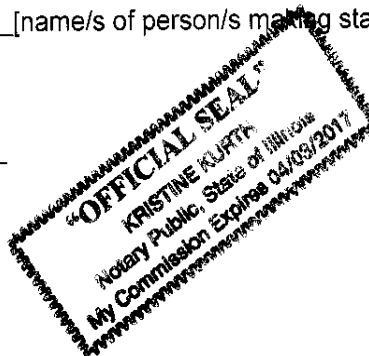
