ORDINANCE NO. 16-06

AN ORDINANCE ANNEXING THE PROPERTY COMMONLY KNOWN AS AT 7148 WEST 72ND STREET TO THE VILLAGE OF BRIDGEVIEW. COOK COUNTY, ILLINOIS


