- 2. Secured Debt and Future Advances. The term "Secured Debt" is defined as follows:

THIS CONDOMINIUM RIDER is made this 28th day of January, 2016, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to U.S. Bank National Association (the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 1411 N State Pkwy, Chicago, IL 60610 [Property

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: 1411 State Parkway Condo [Name of Condominium Project] (the "Condomir.new Project"). If the owners association or other entity which acts for the Condominium Project (the "Owner Association") holds title to property for the benefit or use of its members or shareholders, the Prover'y also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

Condominium Covenants J. addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. Condominium Obligations. Borrower shall perform all of Borrower's obligations under the Condominium Project's Constituent Locuments.
