#### **MORTGAGE**

WITNESSET(): Nortgagor Irrevocably grants, conveys, transfers, and assigns to Lender that real property in Cook County, "", nois commonly known as <u>6416-18 S. St. Lawrence</u>, <u>Chicago</u>, <u>Illinois 60637</u> (the "Property") legally described in Exhibit A, attached hereto.

- Payment of Principal and interest. Mortgagor shall pay, when due, the principal of and interest on the indebtedness evidenced by the Note, any fees and costs provided in the Note, and all other sums secured by this Mortgage.
- 2. Application of Payments. Unless applicable law requires otherwise, all payments received by I one or from Mortgagor under the Note or this Mortgage shall be applied by Lender in the following order of priority: (a) costs payable as provided in the Note; (b) interest payable on the Note; and (c) principal of the Note.
- 3. Charges; Lien: Mortgagor shall pay all water and sewer rates, rents, taxes, assessments, insurance premiums, and other impositions attributable to the Property, when due, directly to the appropriate payee.
- Hazard Insurance. - a. All insurance policies and renewals therac, shall be in a form acceptable to Lender, shall include a standard mortgagee loss payable clause in a form acceptable to Lender. When requested by Lender, Mortgagor shall promptly furnish to Lender written evidence of such insurance policies, all renewal notices and all receipts of paid premiums.
