 - C. I intend to continue to live in the Property as my primar) residence.
 - D. I do not have any other FHA-insured mortgage.
 - E. I am in default under the Loan Documents. My default under the Loan Documents resulted from my verifiable (1) loss of income or (2) increase in living expenses.
 - F. I currently have sufficient income to support the financial obligations under the Loan Documents, as modified by this Agreement.

- 2. Acknowledgements and Preconditions to Permanent Modification. I understand and acknowledge that:
 - A. Prior to the Modification Effective Date as set forth in Section 3 below, if Lender determines that any of my representations in Section 1 above are no longer true and correct, the Loan Documents will not be modified and this Agreement will terminate. In that event, Lender will have all of the rights and emedies provided by the Loan Documents.
 - inc loan Documents will not be modified unless and until (1) Lender approves this Agreement and (2) the Modification Effective Date (as defined in Section 3 below) has occurred. In addition, Lender will not be obligated to modify the Loan Documents if I fail to meet any of the requirements under this Agreement
- The Modification. If all of my representations in Section 1 above continue to be true in all material respects and all preconditions to the modification set forth in Section 2 above have been met, the Loan Documents will automatically become modified on February 1, 2016 (the "Modification Effective Date") and all unpaid late charges that remain unpaid will be waived. If I have failed to make any payments that are a precondition to this modification, this modification will not take effect.
 - A. The new Maturity Date will be January 1, 2046.
 - B. As of the Modification Effective Date, the new principal balance of my Note is \$121,710.71 (the "New Principal Balance"). In servicing your loan, the Bank may have incurred third-party fees or charges that were not included in the terms of this Agreement. If so, these fees and charges will appear on your monthly statement under "Fees and Charges." These fees and charges will not accrue interest or late fees. You may pay these eas and charges at any time.
