THIS CAUSE coming on to be heard upon the Condemnation Complaint of the ILLINOIS STATE TOLL HIGHWAY AUTHORITY (the "Tollway"), for the ascertainment of just compensation to be paid by the Tollway for the taking, uses and purposes stated and set forth therein, to wit, for the taking of fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC, such parcels being legally described in Exhibits "A," "B" and "C," attached hereto and made a part hereof. The Court being advised as set forth herein.

And the Tollway, appearing by Karen Kavanagh Mack, David J. Ben-Dov, and Anda Tatoiu, Special Assistant Attorneys General, and this matter being before this Court, subject to the in personam jurisdiction thereof;

And the Court having jurisdiction over the parties hereto and the cause hereof, and the parties interested herein and such parties being before the Court;

And it appearing to the Court that all defendants have been served with process in the manner provioled by statute;

And it appearing to the Court that Defendants, Estate of Stewart Barrell, deceased, Village of Posen, Victor M. Romero, and the Estate of Joseph Metzger, deceased, have executed disclaimers of interest and have been dismissed as parties in this matter;

And it appearing to the Court that Defendants Benito Juarez (on April 16, 2015), Patricia Juarez (on April 16, 2015), Stacie Schmuckal (on April 17, 2013), Rosemary C. Anderson (on April 17, 2013), Minnie Cabrera (on April 19, 2015), and Demy Cabrera (on August 19, 2015) were properly served with summons and complaint by the Cook County Sheriff and have failed to appear and/or otherwise respond to the Condemnation Complaint filed in this matter;

And it appearing to the Court that Defendants the Estate of E. Heaton, deceased, Henry G. Anguish, Benjamin D. Anguish, Mary E. Blair, Hobart S. Anguish, James A. Anguish, the Estate of Isaac M. Neely, deceased, Cora E. Merrill, and Unknown Owners and Non Record Claimants have been properly served by publication, as provided by statute and that all such defendants have failed to file an appearance in this matter;

And it appearing to the Court from the record of this cause that a Motion was heretofore brought by the Tollway for the immediate vesting in the Tollway of fee simple title to

Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC, pursuant to the statutes of the State of Illinois and, by virtue thereof, on June 12, 2013, this Court found, adjudged and decreed the amount of preliminary just compensation for the taking of fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC to be Eight Hundred, Fifty Dollars & No Cents (\$850.00); that on June 18, 2013, the Totlary deposited said sum with the Treasurer of Cook County, Illinois; that on July 2, 2013, pursuant to the Tollway's motion, an Order was entered vesting the Tollway with fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC;

And the Tollway, having filed its Motion for Entry of Final Judgment Order in the Amount of the Preliminary Award, due notice being given, with said motion requesting that: Defendants Benito Juarez, Patricia Juarez, Stacle Schmuckal, Rosemary C. Anderson, Minnie Cabrera, Demy Cabrera, the Estate of E. Heaton, deceased, Henry G. Anguish, Benjamin D. Anguish, Mary E. Blair, Hobart S. Anguish, James A. Anguish, the Estate of Isaac M. Neely, deceased, Cora E. Merrill, and Unknown Owners and Non-Record Clamants be found in default for failure to appear herein; and further, that the sum of Eight Hundred, Fifty Dollars & No Cents (\$850.00) be determined by this Court to constitute full, final and just compensation for the taking of fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC;

And no party hereto having raised an objection to the Tollway's Motion for Entry of Final Judgment;

AND NOW BEING FULLY ADVISED IN THE PREMISES, THE COURT HEREBY FINDS:

That Defendants Benito Juarez, Patricia Juarez, Stacie Schmuckal, Rosemary C. Anderson, Minnie Cabrera, Demy Cabrera, the Estate of E. Heaton, deceased, Henry G. Anguish, Benjamin D. Anguish, Mary E. Blair, Hobart S. Anguish, James A. Anguish, the Estate of Isaac M. Neely, deceased, Cora E. Merrill, and Unknown Owners and Non-Record Claimants, are in default as a consequence of their failure to file an appearance herein;

And the Court further finds that the amount to be paid by the Tollway as full and final just compensation to the owner or owners of and party or parties interested in the property described in Exhibits "A," "B" and "C" hereto (i.e. Parcels TW-1C-10-230, TW-1C-10-230-TE & TW-1C-10-230-AC), in which the Tollway has acquired fee simple title, a temporary easement and access control is as follows:

To the owner or owners of and party or parties interested in Parcels TW-1C-10-230, TW-1C-10-230-TE and TW-1C-10-230-AC, legally described in Exhibits "A," "B" and "C" hereto, as full and final just compensation therefore to the owner or owners of and party or parties interested therein, the sum of Eight Hundred, Fifty Dollars & No Cents (\$850.00), inclusive of interest and inclusive of any damages to the remainder.

The Court further orders that such compensation is inclusive of damage. If any, to any remainder or adjacent real estate, as a consequence of the taking of fee simple title to Farcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC.

The Court further finds that the payment of said sum to the owner or owners of and party or parties interested in said real property will fully compensate said owner or owners of,

and party or parties interested in, said property for the taking by the Tollway of fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC.

And the Court being fully advised in the premises, Orders and Adjudges that the sums of money herein awarded by the Court to the owner or owners of and party or parties interested in said real property described herein is full and final just compensation, inclusive of interest and inclusive of any damages to the remainder, to the owner or owners thereof and party or parties interested therein to the taking of the said fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC.

This is an award of final and full just compensation, inclusive of interest and inclusive of any damages to the remainder, for the taking by the Tollway of fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-10-230-TE and access control over Parcel TW-1C-10-230-AC, and not an award of prominary just compensation relative to the taking thereof.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED THAT:

- 1. The Order of the Court of June 12, 2013, vesting the Tollway with fee simple title to Parcel TW-1C-10-230, a temporary easement across and upon Parcel TW-1C-16-230-TE and access control over Parcel TW-1C-10-230-AC is hereby confirmed in all respects;
- 2. The sum of Eight Hundred, Fifty Dollars & No Cents (\$850.00), was deposited by the Tollway with the Treasurer of Cook County on June 18, 2013; therefore, the Tollway shall be deemed to have fully satisfied this Final Judgment Order; and


3. This judgment is hereby declared satisfied and this matter is hereby stricken from




