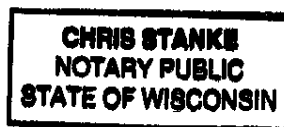

THAT PART OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 26, TOWNSHIP 41 NORTH, RANGE 9, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SAID SECTION 26; THENCE NORTHERLY ALONG THE EAST LINE OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4, A DISTANCE OF 28.7 FEET TO A POINT ON THE CENTER LINE OF U.S. ROUTE 20 FOR THE PLACE OF BEGINNING; THENCE CONTINUING NORTHERLY ALONG THE EAST LINE OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4, A DISTANCE OF 333.41 FEET; THENCE WESTERLY AT RIGHT ANGLES TO THE LAST DESCRIBED COURSE, A DISTANCE OF 286.56 FEET; THENCE SOUTHERLY PARALLEL WITH THE EAST LINE OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4, A DISTANCE OF 242.61 FEET TO THE CENTER LINE OF U.S. ROUTE 20; THENCE SOUTHEASTERLY ALONG SAID CENTER LINE A DISTANCE OF 300.0 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS.
