AMENDMENT TO MEMORANDUM OF LEASE

This Amendment to Memorandum of Lease is made effective as of the later of the signature dates below between NORTH SUBURBAN YOUNG MEN'S CHRISTIAN ASSOCIATION, an Illinois Not-for-Profit corporation ("Landlord") and TOWERCO IV LLC, a Delaware limited liability company ("Tenant").

- 1. Landlord and Tenant (as successor in interest to New Cingular Wireless PCS, LLC) are parties to that certain Option and Lease Agreement dated December 18, 2013 (as amended, the "Agreement") for certain real property and easements (collectively the "Premises") which are a portion of that real property owned by Landlord located in the City of Northbrook, County of Cook, State of Illinois.

- 5. Landlord and Tenant have amended the Agreement and desire to amend the MOL to reflect the changes set forth in the Agreement amendment.
 - 6. The MOL is amended as follows:
- (a) <u>Background Paragraph</u> The reference to "Exhioit 1" in paragraph 3 of the MOL is deleted and "Exhibit 1-A" is inserted in lieu thereof as attached hereto.
- (b) <u>Legal Descriptions</u>. The Premises leased by Tenant is approximately 1,951 square feet of land (25'8" x 76') as shown on attached Exhibit 1-A. Attached Exhibit 1-A shall replace Exhibit 1 of the MOL.
- 7. In the event of any inconsistencies between the terms of the MOL, as amended by this amendment, and the Agreement, the term set forth in the Agreement shall control.
