- 3. To endorse any checks or other instruments received by Wells Fargo Bank, National Association and made payable to Trustee.
- 4. To pursue any deficiency, debt or other (bligation, secured or unsecured, including but not limited to those arising from foreclosure or other sale, promissory note or check.
