- (2) That certain Line of Credit Note (Frogram), dated February 9, 2016 in the original principal amount of Forty-Two Million Five Hundred Thousaid and 90/100 Dollars (\$42,500,000.00), executed and delivered by Napleton Schaumburg Motors, Inc., Napleton's Schaumburg Pontiac-GMC, Inc., Napleton's Schaumburg Subaru, Inc., Napleton's Elgin Motors Holding Inc. and Northwestern Chrysler-Plymouth Sales, Inc. to the Mortgagee, which Line of Credit Note (Floorplan) evidences a modification of indebtedness evidenced by the certain Line of Credit Note (Floorplan), dated January 9, 2013 in the original principal amount of Fifteen Million Nine Hundred Thousand and 00/100 Dollars (\$15,900,000.0), executed and delivered by Napleton Schaumburg Motors, Inc. and Napleton's Schaumburg Pontiac-GMC, Inc. 15 the Mortgagee, as previously amended, modified and/or replaced.
