Midland States Bank has a security interest in the Subject Property pursuant to the following mortgage documents (collectively, the "Mortgage Documents"):

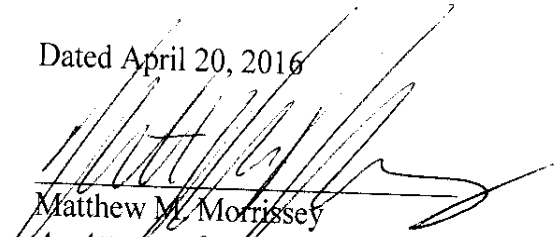

Jach executed the Modification of Mortgage in favor of Midland (as successor to First National Bank of Grant Park) on July 12, 2011 to secure an \$8,418.26 increase in the principal amount of the original loan amount which increased the total amount owed to \$300,918.26.
3. A Real Estate Mortgage which was filed for record on September 21, 2011 with the Cook County Recorder of Deeds as Document Number 1126419027 (the "July 2011 Mortgage"). Gregory A. Jach executed the July 2011 Mortgage on July 12, 2011 to secure the \$8,418.26 increase in the principal amount of the original loan amount which increased the total amount owed to \$300,918.26.

These Mortgage Documents are the subject of the foreclosure count of this action.

Gregory A. Jach currently holds title to the Subject Property.

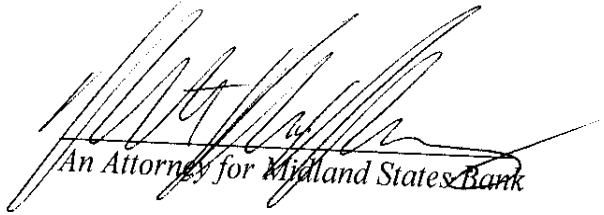
