- 7. Preservation, Maintangue and Protection of the Property; Inspections. Such loss reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings or such loss reserve.
