BORROWER COVENANTS that the Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Pryment of Principal; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of the debt evidenced by the Note and any prepayment and late charges due under the Note and any sums advanced under paragraph 7.

Borrower shall keep the Property in good repair and shall not destroy, damage or impair the Imperty, allow the Property to deteriorate, or commit waste on the Property. Borrower shall be in drively if any forfeiture action or proceeding, whether civil or criminal, is begun that in Lender's good (a) h judgment could result in forfeiture or the Property or otherwise materially impair the lien created by this Security Instrument or Lender's security interest.
