ORDINANCE

AN ORDINANCE TERMINATING SPECIAL SERVICE AREA NUMBER TWO

WHEREAS, an ordinance establishing Special Service Area Number Two in the Village of Oak Park ("SSA #2") was adopted on August 18, 1975, for the purpose of providing special municipal services to the area bounded by Austin Boulevard on the east, North Boulevard on the south; Humphrey Avenue on the west and the East-West alley north of and parallel to Lake Street on the North, in addition to services provided to the Village generally; and

WHERFAS, the purpose of this Ordinance is to terminate SSA #2.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cock County, Illinois, in the exercise of their home rule powers, as follows:

- **Section 1. Recitals incorporated.** The above recitals are incorporated herein by reference as though fully set fort 1.
- **Section 2. Termination**. The special service area established by Ordinance 1975-O-52, being an Ordinance Establishing SSA #2, is hereby terminated, and the SSA #2 shall be terminated as of the effective date of this Ordinance.
- **Section 3.** Recording and Filing of Ordinance. The Village Attorney or his designee is hereby authorized and directed to record a copy of this Ordinance terminating SSA #2 with the Cook County Recorder of Deeds and provide a copy of this Ordinance to the Cook County Clerk.
- **Section 4. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.
- **Section 5. Effective Date.** This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
