#### **MORTGAGE**

THIS MORTGAGE, made as of April 26<sup>th</sup>, 2016 by MACK INDUSTRIES II, LLCwhose principal place of business is 6820 Centennial Dr., Tinley Park, Illinois(herein referred to as "Mortgagor"), in favor of FIRST COMMUNITY FINANCIAL BANK, whose principal place of business is 13901 S.
