AN ORDINANCE APPROVING A PLAT OF DEDICATION FOR A PORTION OF THE PROPERTY LOCATED AT 7941 LINCOLN AVENUE, SKOKIE, ILLINOIS IN A CX CORE MIXED-USE DISTRICT

WHEREAS, the owner of the following described real property:

THE EASTERLY 2.00 FEET OF LOT 12, AND THE EASTERLY 2.00 FEET OF THE NORTHERLY 15.50 FFET OF LOT 13 IN BLOCK 2 IN THE CIRCUIT COURT PARTITION OF LOTS 2, 7, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17 AND 18 IN WILLIAM LILL ADMINISTRATOR'S SUBDIVISION OF THE NORTHEAST QUARTER OF SECTION 28, TOWISHIP 41 NORTH, RANGE 13 EAST, EXCEPTING THEREFROM THAT PORTION THEREOF FALLING WITHIN LOTS 5 AND 6 OF THE COUNTY CLERK'S DIVISION O'- SECTION 28 AFORESAID; IN COOK COUNTY, ILLINOIS.

WHEREAS, the Village has determined that subsequent to the dedication of the Subject Property, the property located at 7941 Lincoln Avenue, as a whole, will be deemed to be legal non-conforming due to the reduced size of the setbacks. The property owner has relied on this determination in making the dedication of the Subject Property. Any required permits related to building and construction on the property, subsequent to this dedication, will be issued as long as all other requirements are met; and

WHEREAS, the Community Development Department Director reviewed the request for the dedication and recommended to the Mayor and Board of Trustees that the requested dedication be approved as stated in his memorandum dated December 8, 2015; and WHEREAS, the Mayor and Board of Trustees, at a public meeting duly held on February 1, 2016 concurred in the aforesaid recommendation of the Community Development Department Director; NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Illinois: That the above stated Recitals are restated and incorporated as if stated in full. Section 2: That the dedication of the Subject Property, legally described above and commonly known as a portion of 7941 Lincoln Avenue, Skokie, Illinois, in a CX Core Mixed-Use district, as denicted on the "Plat of Dedication", dated November 24, 2015 and subsequently revised December 4, 2015, be approved. Section 3: That the Plat of Dedication", dated November 24, 2015 and subsequently revised December 4, 2015, attached as "Exhibit 1", except as it may be revised subject to the approval of the Corporation Counsel and the Village Manager or designee, be and the same is hereby accepted. The Plat shall be recorded with the Cook County Recorder of Deeds Office. That a notice of the approval of this Ordinance incorporating the Section 4: conditions contained herein shall be executed by the owner of the property in writing and duly recorded with the Cook County Recorder of Deeds Office at the owner's expense. 


