AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS **FOR** OLD ORCHARD GREENS CONDOMINIUM "NEW TON HOUSE"

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for Old Orchard Greens Condominium "Newton House" Condominium Association (hereafter the "Association"), which Declaration was recorded on August 5, 1965, as Document No. 19548782 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "P or erty") legally described in Exhibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article XIII, Section 7 of the aforesaid Declaration and Section 17 and Section 18.8(a) of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), signed by the members of the Board, and by unit owners having at least three-fourths (3/4) of the total vote, and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees, having liens of record against any unit ownership, not less than ten (10) days prior to the date of such affidavit.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Board and the Owners desire to amend the Declaration in order to address Unit Owner responsibility for damages arising from the use of their Unit, Unit Owner insurance, and the deductible portion of the Association's property insurance; and

WHEREAS, the amendment has been executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), signed by the members of the Board, and by unit owners having at least three-icurths (3/4) of the total vote, all in compliance with Article XIII, Section 7 of the Declaration and Section 17 and Section 18.8(e) of the Act.

NOW THEREFORE, Article V of the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Old Orchard Greens Condominium "Newton House" is hereby amended in accordance with the text which follows (additions in text are indicated by <u>double underline</u>; deletions by <u>strike-outs</u>):

- "7. Unit Owner Responsibilities. (a) Every Unit Owner is responsible to maintain a clear and open drain for the air conditioning condensing line, dishwasher, garbage disposal, shower, and any other drains, serving their Unit, and such Unit Owner shall be responsible for damages resulting from failure to do so.
- (b) A Unit Owner shall be liable to the Association and/or another Unit Owner or Occupant of a Unit for any claim, damage or judgment entered as a result of the use or operation of his/her Unit or caused by his/her own conduct or the conduct of his/her guest, invitee, tenant or pet.
- (c) Each Unit Owner shall be responsible for obtaining insurance on the contents of his or her own Unit, as well as additions and improvements thereto, decorating (including, but not limited to, carpeting, floor finish, paint, wallpaper, paneling and tile), furnishings and personal property therein.
- (d) Each Unit Owner shall obtain, and shall provide evidence thereof to the Association, insurance covering their personal liability and compensatory (but not consequential) damages to another Unit caused by the negligence of the Unit Owner or his or her guests, residents, or invitees, or regardless of any negligence originating from the Unit. The personal liability of a Unit Owner or Association member must include the deductible of the Unit Owner whose Unit was damaged, any damage not covered by insurance required by this subsection, as well as the decorating, painting, wall and floor coverings, trim, appliances, equipment, and other furnishings.

(e) The Board of the Association may, in the case of a claim for damage to a Unit or the Common Elements covered by the Association's property insurance, (i) pay the deductible amount as a common expense, (ii) after notice and an opportunity for a hearing, assess the deductible amount against the Owners who caused the damage or from whose Units the damage or cause of loss originated, or (iii) require the Unit Owners of the Units affected to pay the deductible amount."


