AGREED JUDGMENT ORDER


THIS CAUSE coming on to be heard before this Court, the Court being fully advised in the premises and the parties being in agreement.

IT IS HEREBY ORDERED THAT:

1. Judgment is hereby entered by agreement in favor of the Plaintiff, National Collegiate Student Loan Trust 2006-1, and against the Defendant, Willye Jones in the amount of \$9510.55 plus court costs.
2. Defendant shall pay the judgment balance with 0% interest on the principal balance at a rate of a \$25.00 per month starting 6/15/2015 and each month thereafter until the sum is paid in full. Defendant waives process of service and submits to the court's jurisdiction.
3. Should the Defendant fail to tender the payments as agreed and upon notice of motion, Plaintiff shall have leave to move the Court to vacate the installment portion of this order and execute on the Judgment.
