- (a) <u>Maturity Date of Notes.</u> As of the date hereof, the Notes are scheduled to be paid in full on June 15, 2016.
- 3. <u>Representations and Warranties</u>. The representations, warranties and covenants set forth in the Mortgage shall be deemed remade and affirmed as of the date hereof by Mortgagor, except that any and all references to the Agreement in such representations, warranties and covenants shall be deemed to include this Amendment.
- 4. <u>Relation Back</u>. It is the intent of Mortgagor and Mortgagee that the First Amendment to Mortgage, Second Amendment to Mortgage, Third Amendment to Mortgage,

Fourth Amendment to Mortgage, Fifth Amendment to Mortgage, Sixth Amendment to Mortgage and this Amendment will relate back to and be effective as if adopted on October 20, 2006.

- 5. <u>Effectuation</u>. The amendments to the Mortgage contemplated by this Amendment shall be deemed effective immediately upon the full execution of this Amendment and without any further action required by the parties hereto. There are no conditions precedent or subsequent to the effectiveness of this Amendment.
- 6. <u>Incorporation of Recitals</u>. The recitals set forth in the "Witnesseth" Section of this Amendment are hereby incorporated into and made a part of this Amendment as if fully set forth in the body of this agreement.
- 7. Counterparts. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.
