The Lien Claimant satisfactorily completed and fulfilled its obligation to renovations of 7950 S Greenwood Chicago, IL 60620 on 04/15/2016, and the Owner having inspected and approved of the work completed. To date the LienClaimant has received a down payment toward the project paid from monthly rent collections billed in the amount of \$6,000.00, thus leaving a balance due of \$60,200.00, which includes the cost of any additional work, if any, completed upon the request of the Owner.
