This MODIFICATION OF LOAN DOCUMENTS (this "<u>Agreement</u>") is dated as of May 31, 2016, and is executed by and among (i) DEAN M EBERHARDT, TRUSTEE OF THE DEAN M. EBERHARDT TRUST (the "<u>Borrower</u>"), (ii) MRC POLYMERS, INC., an Illinois corporation (the "<u>Guarantor</u>"), and (iii) FIRSTMEFIT BANK, N.A., a national banking association (together with its successors and assigns, the "<u>Ler ter</u>").

RECITALS:

- A. Reference is made to that certain Revolving Mortgage, Security Agreement, Assignment of Rents and Leases and Fixture Filing dated as of October 18, 2010, recorded with the Recorder of Deeds in Cook County, Illinois (the "Recorder's Office"), on October 22, 2010, as Document No. 1029533021 (together with all amendments thereto, the "Mortgage"), which Mortgage encumbers the real property and all improvements thereon legally described on Exhibit "A" attached to this Agreement (the "Premises"). Capitalized terms not otherwise defined herein shall have the meanings given to them in the Mortgage.
- B. Borrower has requested that Lender modify the Mortgage Note, pursuant to the terms of a Note Modification Agreement between Borrower and Lender of even date herewith (the "Note Modification Agreement").
- C. Guarantor and MRC Management (collectively, "<u>Commercial Borrowers</u>") have requested that Lender modify the Loan Agreement, Commercial Loans and Commercial Notes,

pursuant to the terms of (i) a Third Amended and Restated Credit Agreement between Commercial Borrowers and Lender of even date herewith ("Third Amended and Restated Credit Agreement"), (ii) a Third Amended and Restated Revolving Note from Commercial Borrowers in favor of Lender of even date herewith, evidencing a maximum principal indebtedness of SIX MILLION AND 00/100 DOLLARS (\$6,000,000.00) ("Third Amended and Restated Revolving Note"), (iii) a Consolidated, Amended and Restated Capex 1 Loan Note from Commercial Borrowers in favor of Lender of even date herewith, evidencing a maximum principal indebtedness of ONE MILLION SEVEN HUNDRED FIFTY THOUSAND THREE HUNDRED THIRTY-SIX AND 57/100 DOLLARS (\$1,750,336.57) ("Consolidated, Amended and Restated Capex 1 Loan Note"), (iv) a Capex 2 Loan Note from Commercial Borrowers in favor of Lender of even date herewith, evidencing a maximum principal indebtedness of TWO HUNDRED FIFTY THOUSAND AND 00/100 DOLLARS (\$250,000.00) (Canex 2 Loan Note"), and (v) an Amended and Restated Term loan Note from Commercial Borrowers in favor of Lender of even date herewith, evidencing a maximum principal indebtedness of THREE MILLION FORTY-FIVE THOUSAND THIRTY AND 16/100 DOLLARS (\$3,045,030.16) ("Amended and Restated Term Loan Note").

D. It is a condition precedent to the Lender's agreement to enter into the Note Modification Agreement and the Third Amended and Restated Credit Agreement that the Borrower and the Guarantor execute and deliver this Agreement to the Lender.

<u>AGREEMENTS</u>:

NOW, THEREFORE, in consideration of (i) the facts set forth in the above Recitals (which are incorporated into and made a part of this Agreement), (ii) the agreements by the Lender to modify the Mortgage Loan Documents, as provided in this Agreement, (iii) the covenants and agreements contained in this Agreement, and (iv) for other good and valuable consideration, the receipt, adequacy, and sufficiency of which are acknowledged, the parties agree as follows:

- 1. **RECITALS**. The foregoing Recitals are made a part of this Agreement.
- **2.** <u>DEFINITIONS</u>. Unless otherwise defined in this Agreement, any capitalized word or phrase used in this Agreement has the definition ascribed to such word or phrase in the Mortgage.
- 3. MODIFICATION OF MORTGAGE, ASSIGNMENT OF RENTS AND INDEMNITY AGREEMENT. Effective as of the date of this Agreement, each of the Mortgage, the Assignment of Rents, and the Indemnity Agreement are amended as follows:
- 3.1 <u>Credit Agreement</u>. The terms "<u>Credit Agreement</u>" and "<u>Loan Agreement</u>" are amended to mean the Third Amended and Restated Credit Agreement.
- 3.2 <u>Commercial Borrowers</u>. The term "<u>Commercial Borrowers</u>" is amended to mean the Commercial Borrowers as set forth above.
- mean the aggregate amount of **ELEVEN MILLION FORTY-FIVE THOUSAND THREE**

HUNDRED SIXTY-SIX AND 73/100 DOLLARS (\$11,045,366.73) loaned by the Lender to the Commercial Borrowers pursuant to the Third Amended and Restated Credit Agreement. The Commercial Loans are evidenced by the Commercial Notes. Accordingly, the total amount of Loans secured by the Mortgage is TWELVE MILLION THREE HUNDRED ONE THOUSAND ONE HUNDRED SIX AND 73/100 DOLLARS (\$12,301,106.73).

- 3.4 <u>Commercial Notes</u>. The term "<u>Commercial Notes</u>" is amended to mean the Third Amended and Restated Revolving Note, the Consolidated, Amended and Restated Capex 1 Loan Note, the Capex 2 Loan Note, and the Amended and Restated Term Loan Note.
- Note, whether using the words "Maturity Date" or a reference to a specific date, are amended to reflect a Maturity Date of May 31, 2023.
- 4. TITLE FOLICY. As a condition precedent to the agreements contained in this Agreement, the Borrow of shall, at its sole cost and expense, cause Chicago Title Insurance Company to issue an endorsement to the Lender's title insurance policy No. 1410 008815284 EP (the "Title Policy"), as of the date this Agreement is recorded, reflecting title to the Premises being vested in the Borrower, reflecting the recording of this Agreement and insuring the first priority of the lien of the Mortgage, subject only to the exceptions set forth in the Title Policy as of its date of issuance and any other creumbrances expressly agreed to by the Lender (the "Endorsement").
- 5. <u>DELIVERIES</u>. As conditions precedent to the effectiveness of this Agreement, the Borrower must deliver or cause to be delivered or satisfied the following, all of which must be in form, substance, and execution acceptable to the Lender and counsel for the Lender:
- 5.1 Agreement. This Agreement, executed by the Borrower, the Guarantor and the Lender.

5.2 Organizational Documents and Resolutions.

- (a) A current Certificate of Good Standing from the Secretary of State of the State of Illinois for the Guarantor.
- (b) A certified copy of the Articles of Incorporation and By Laws for the Guarantor and all amendments thereto, or a certification by a duly authorized officer of the Guarantor that the same have not been amended or modified since the date certified copies of the same were submitted to the Lender.
- (c) A certified copy of a unanimous written consent executed by the board of directors of the Guarantor, authorizing the Guarantor's execution and delivery of this Agreement.
- (d) A Certified Abstract of Trust from the trustee of the Borrower in a form acceptable to the Lender, authorizing the Borrower's execution and delivery of this Agreement and all other documents and instruments required to be executed and delivered in connection herewith.

- **5.3 Endorsement**. The Endorsement.
- **5.4** Other Documents. Such other documents, instruments, agreements, and financial information as the Lender may reasonably require.
- 6. REPRESENTATIONS, WARRANTIES AND COVENANTS OF BORROWER. The Borrower represents, covenants, and warrants to the Lender as follows:
- 6.1 <u>Representations and Warranties</u>. The representations and warranties in the Mortgage Note, the Mortgage, and the other Mortgage Loan Documents are true and correct in all material respects as of the date of this Agreement.
- Event of Default. There is currently no Event of Default under the Mortgage Note, in Mortgage, or the other Mortgage Loan Documents and the Borrower does not know of any event or circumstance which with the giving of notice or passing of time, or both, would constitute an Event of Default under the Mortgage Note, the Mortgage, or the other Mortgage Loan Documents
- 6.3 Full Fore: and Effect. The Mortgage Loan Documents as modified by this Agreement are in full force and effect and, following the execution and delivery of this Agreement, continue to be the legally valid and binding obligations of the Borrower enforceable in accordance with their respective terms, subject to limitations imposed by general principles of equity.
- 6.4 No Material Adverse Change. There has been no material adverse change in the financial condition of the Borrower of any other party whose financial statement has been delivered to the Lender in connection with the Mortgage Loan from the date of the most recent financial statement received by the Lender.
- 6.5 No Claims or Defenses. As of the date of this Agreement, the Borrower does not have any claims, counterclaims, defenses, or set-offs with respect to the Mortgage Loan or the Mortgage Loan Documents as modified in this Agreement.
- and authority to execute and deliver this Agreement. The execution and delivery of this Agreement have been duly authorized by all requisite action by or on behalf of the Borrower. obligations and liabilities under the Guaranty will continue in full force and that the execution and delivery of this Agreement to, and its acceptance by, the Lender will not in any manner whatsoever (i) impair or affect the liability of the Guarantor to the Lender under the Guaranty, (ii) prejudice, waive, or be construed to impair, affect, prejudice, or waive the rights and abilities of the Lender at law, in equity, or by statute, against the Guarantor pursuant to the Guaranty, and/or (iii) release or discharge, nor be construed to release or discharge, any of the obligations and liabilities owing to the Lender by the Guarantor under the Guaranty; and (e) represents and warrants that each of the representations and warranties made by the Guarantor in the Guaranty remain true and correct as of the date hereof.

EXPENSES. As a condition precedent to the agreements contained in this Agreement, the Borrower must pay all out-of-pocket costs and expenses incurred by the Lender in connection with this Agreement, including, without limitation, title charges, recording fees, appraisal fees, and reasonable attorneys' fees and expenses.

9. RELEASE AND WAIVER OF CLAIMS.

General Release and Waiver of Claims. In consideration of the Lender's agreement to enter into this Agreement, the Borrower and the Guarantor jointly and severally release and forever discharge the Lender and its respective successors, assigns, partners, directors, officers, agents, attorneys, administrators, trustees, subsidiaries, affiliates, beneficiaries, shareholders, representatives, agents, servants, and employees from any and all rights, proceedings, agreements, contracts, judgments, debts, costs, expenses, promises, duties, claims, demands, cross-actions, controversies, causes of action, damages, rights, liabilities, and obligations, at law or in equity whatsoever, knews or unknown, suspected or unsuspected. choate or inchoate, whether past, present, or future, row held, owned, or possessed by the Borrower or the Guarantor, or which the Borrower or the Guarantor may hereafter hold or claim to hold from the beginning of time to the date of this Agreen ent under common law or statutory right, known or unknown, arising, directly or indirectly, proxinately or remotely, out of the Mortgage Note, the Mortgage, or any of the other Mortgage Loan Documents, including, without limitation, any and all rights, proceedings, agreements, contracts, judgments, debts, expenses, promises, duties, claims, demands, cross-actions, controversies, cause of action, damages, rights, liabilities, and obligations whether based upon tort, fraud, breach of any duty of fair dealing, breach of confidence, undue influence, duress, economic coercion, conflict of interest, negligence, bad faith, intentional or negligent infliction of mental distress, tortious interference with contractual relations, tortious interference with corporate governance or prospective business advantage, breach of contract, deceptive trade practices, libel, slander, conspiracy, any claim for wrongfully accelerating the Mortgage Loan or wrongfully attempting to foreclose on any collateral relating to the Mortgage Loan, contract, or usury, but only to the extent that the foregoing arise in connection with events which occurred prior to the date of this Agreement. Without limiting the generality of the foregoing, this release includes the following matters: (a) all aspects of this Agreement, the Mortgage Note, the Mortgage, the other Mortgage Loan Documents, and the negotiations among or on behalf of the Borrower, the Guarantor and the Lender and the demands and requests by the Lender of the Borrower and/or the Guarantor concerning this Agreement and the other Mortgage Loan Documents, including, but not limited to, all meetings, telephone calls, correspondence, and/or other contacts among or on behalf of the Borrower, the Guarantor, and the Lender incident to the attempts of said parties to reach an

agreement in connection herewith, or in connection with the Mortgage Note, the Mortgage, or any of the other Mortgage Loan Documents and the attempt(s) of the Lender to collect the Mortgage Note, and (b) the exercise by the Lender of its rights under the Mortgage Note, the Mortgage, or any of the other Mortgage Loan Documents or at law or in equity.

This release is intended to release all liability of any character claimed for damages, of any type or nature, for injunctive or other relief, for attorneys' fees, interest, or any other liability whatsoever, whether statutory, contractual, or tort in character, or of any other nature or character in any way related to any and all matters and dealings of any nature whatsoever asserted or assertable by or on behalf of the Borrower or the Guarantor against the Lender, including, without limitation, any loss, cost, or damage in connection with, or based upon, any breach of fiduciary duty, breach of any duty of fair dealing or good faith, breach of confidence, breach of funding commitment, breach of any other duty, breach of any statutory right, fraud, usury redue influence, duress, economic coercion, conflict of interest, negligence, bad faith, malpractice violations of the Racketeer Influenced and Corrupt Organizations Act, intentional or negligent intliction of mental distress, tortious interference with corporate or other governance or prospective basiness advantage, breach of contract, deceptive trade practices, libel, slander, conspiracy, or any siner cause of action, but only to the extent that the foregoing arise in connection with events which occurred prior to the date of execution hereof.

The Borrower and the Guzzantor understand and agree that this is a full, final, and complete release and agree that this release may be pleaded as an absolute and final bar to any or all suit or suits pending or which may thereafter be filed or prosecuted by the Borrower or the Guarantor or anyone claiming by, through, or under the Borrower or the Guarantor in respect of any of the matters released by this Agreement and that no recovery on account of the described matters may hereafter be had from anyone whomsoever, and that the consideration given for this release is no admission of liability and that neither the Borrower, the Guarantor, nor those claiming under the Borrower or the Guarantor will over claim that it is.

9.2 Releases Binding on Affiliates. The provisions, waivers, and releases set forth are binding upon the Borrower and the Guarantor and their respective agents, employees, representatives, officers, directors, general partners, limited partners, joint shareholders, beneficiaries, trustees, administrators, subsidiaries, affiliates, employees, servants, and attorneys.

10. MISCELLANEOUS.

- 10.1 <u>Governing Law</u>. This Agreement is governed by and will be construed in accordance with the laws of the State of Illinois.
- 10.2 <u>Construction</u>. This Agreement may not be construed more strictly against the Lender than against the Borrower or the Guarantor merely by virtue of the fact that the same has been prepared by counsel for the Lender, it being recognized that the Borrower, the Guarantor, and the Lender have contributed substantially and materially to the preparation of this Agreement, and the Borrower, the Guarantor, and the Lender each acknowledges and waives any claim contesting the existence and the adequacy of the consideration given by the other in entering into this Agreement. Each of the parties to this Agreement represents that it has been advised by its respective counsel of the legal and practical effect of this Agreement,

and recognizes that it is executing and delivering this Agreement, intending to be legally bound by the terms and provisions of this Agreement, of its own free will, without promises or threats or the exertion of duress upon it. The signatories state that they have read and understand this Agreement, that they intend to be legally bound by it, and that they expressly warrant and represent that they are duly authorized and empowered to execute it.

- 10.3 <u>No Joint Venture</u>. Notwithstanding the execution of this Agreement by the Lender, nothing contained in this Agreement may be considered to constitute the Lender a venturer or partner of or in any way associated with the Borrower or the Guarantor nor will privity of contract be presumed to have been established with any third party.
- **10.4** Prior Agreements. The Borrower, the Guarantor, and the Lender each acknowledges that there are no other understandings, agreements, or representations, either oral or written, express or implied, that are not embodied in the Mortgage Loan Documents and this Agreement, which collectively represent a complete integration of all prior and contemporaneous agreements and understandings of the Borrower, the Guarantor, and the Lender; and that all such prior understandings, agreements, and representations are modified as set forth in this Agreement. Except as expressly modified by this Agreement, the terms of the Mortgage Loan Documents are and remain unmodified and in full force and effect.
- 10.5 <u>Successors and A. signs</u>. This Agreement binds and inures to the benefit of the parties to this Agreement and their respective heirs, executors, administrators, successors, and assigns.
- 10.6 References to Loan Documents. Any references to the Mortgage Note, the Mortgage, or any of the other Mortgage Loan Documents contained in any of the Mortgage Loan Documents will be considered to refer to the Mortgage Note, the Mortgage, or any of the other Mortgage Loan Documents as amended. The paragrap's and section headings used in this Agreement are for convenience only and do not limit the substantive provisions of this Agreement. All words in this Agreement that are expressed in the pouter gender are deemed to include the masculine, feminine, and neuter genders. Any word in this Agreement that is expressed in the singular or plural is deemed to include, whenever appropriate in the context, the plural and the singular.
- 10.7 <u>Counterparts</u>. This Agreement may be executed in one or more counterparts, all of which, when taken together, constitute one original Agreement.
- 10.8 <u>Time of the Essence</u>. Time is of the essence of each of the Borrower's obligations under this Agreement.
