AMENDMENT TO THE PRESERVATION DECLARATION OF THE LANDMARK

This document is recorded for the purpose of amending The Preservation of Landmark Declaration (hereafter the "Declaration") for The Landmark Residence Preservation Association (hereafter the "Association"), which Declaration was recorded on December 3, 1980, as Document No. 25691004 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article VII, Section D of the aforesaid Declaration and Section 1-20(b) of the Illinois Common Interest Community Association Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Directors of the Association (the "Board"), and by Owners representing at least two-thirds (2/3) of the total vote of all Eligible Votes.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Declaration; and

WHEREAS, the Board and the Owners desire to amend the Declaration concerning the leasing of Residential Units; and

WHEREAS, the amendment has been executed by the President of the Association or such other officer authorized by the Board, and by Owners representing

at least two-thirds (2/3) of the total vote of all Eligible Votes, all in compliance with Article VII, Section D of the Declaration and Section 1-20(b) of the Act.

NOW THEREFORE, Article XI, Section D of The Preservation of Landmark Declaration (hereafter the "Declaration") for The Landmark Residence Preservation Association is hereby amended in accordance with the text which follows (additions in text are indicated by <u>double underline</u>; deletions by <u>strike-outs</u>):

"9. Leasing of a Residential Unit.

(i) Norwithstanding any other provisions of the Declaration to the contrary, no Residential Unit permitted to be leased shall be used for hotel or transient purposes or subleased, no Owner shall lease less than the entire Residential Unit, and all permitted leases shall be in writing, for a term of at least twelve (12) months, and shall be subject to the terms of the Declaration, By-Laws, and the rules established by the Board. The Owner of a Residential Unit being leased as permitted hereunder shall provide the Association with the names and contact information of all tenants of the Residential Unit, including the tenents' family members who will occupy the Residential Unit, and only those persons may reside in the Residential Unit. The provisions of the Declaration, By-Laws and rules and regulations that relate to the use of the individual Residential Unit or the Common Area shall be applicable to any person leasing a Unit and shall be deemed to be incorporated in any lease. With regard to any lease, the Owner leasing the Residential Unit shall deliver a copy of the signed lease to the Board not later than the date of occupancy or ten (16) days after the lease is signed, whichever occurs first. In addition to any other remedies, by filing an action jointly against the tenant and the Owner, the Association may seek to enjoin a tenant from occupying a Residential Unit or seek to evict a tenant under the provisions of Article IX of the Code of Civil Procedure for failure of the lessor-Owner to comply with the leasing requirements prescribed by the Declaration, By-Laws, and rules and regulations. The Board of Directors may proceed directly against a tenant, at law of in equity, or under the provisions of Article IX of the Code of Civil Procedure, for any ciner breach by a tenant of any covenants, rules, regulations or By-Laws. An Owner may not assign, delegate, transfer, surrender, or avoid the duties, responsibilities, and liabilities of an Owner under, the Declaration, By-Laws, or rules and regulations of the Association; and such an attempted assignment, delegation, transfer, surrender, or avoidance shall be deemed void."

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration and By-Laws shall continue in effect without change.
